7. Contestants **MUST** attend the practice for pageant held on July 22, 2018 at 12:00 noon in the Show Barn.

Rules and Duties

1. Each contestant MUST be a resident of Loudoun County.
2. Each contestant MUST be a member of a Loudoun County 4-H club.
3. Contestants must be at least 16 years of age by July 22, 2018, and not over 19 years of age by January 1, 2019.
4. Contestants must have never been married, nor had any children, and must be females who have always been females.
5. Contestants must be of good moral character, never been convicted of any crime, never had any criminal charges pending against them, and never done any act or engaged in any activity which is or could be characterized as dishonest, immoral, indecent, or in bad taste.
6. Contestants will be judged on 4-H and Fair involvement, personality, and poise.
7. Winner must be at the 2018 Loudoun County Fair all week to hand out ribbons and awards according to the Fair schedule of events.
8. The winner may compete in January 2019 at the Virginia Association of Fairs Pageant.
9. The winner will be required to carry the title of Miss Loudoun County Fair in any other events she participates.
10. The winner will be present at the 2019 Miss Loudoun County Fair Pageant to crown the new winner.
11. Contestants MUST attend practice for the pageant held on July 22, 2018 at 12:00 noon in the Show Barn.
12. Registration Deadline: Monday, July 16, 2018.
13. Entries will be limited to the first 15 applicants.
